#### **SCOTT TILLEMA**

Scott is an internationally recognized crisis negotiator, advisor, trainer and keynote speaker. He is known and respected for his experience negotiating in highly charged situations, with high stakes and when the situation requires sensitivity to the human element. Clients, audiences and students a like, find Scott's teachings, insightful, inspiring and pragmatic.

Scott has over 20 years of law enforcement experience in the United States and retired from a Chicago area police department in 2023 at the rank of Lieutenant.

In 2007, he was trained by the FBI in hostage and crisis negotiation and has been involved in the field since that time. Scott worked as a negotiator with one of the largest regional SWAT teams in the U.S. for many years before moving into the role of a negotiations speaker and trainer.

He has studied negotiation at the Harvard University Program on Negotiation, at IMD Business School, and he continues to receive training from the world's top negotiators.

Scott is a prolific trainer within the negotiation field and travels the country and around the world speaking to a wide variety of audiences. He has taught negotiations at Harvard University, for the FBI, and has keynoted for companies such as Microsoft and Bosch. In 2016, he was invited to give a TEDx talk titled "The Secrets of Hostage Negotiators", which has received over 1 million views. His visibility as a speaker and educator through TEDx and other venues has reached global status.

Scott currently resides in the Chicago area and is a Partner and co-founder with the Negotiations Collective.

#### JAY ALLEN

After seeing his mother suffer from Alzheimer's, Allen wrote "Blank Stares". A video of him performing the song with his mother on stage in lowa went viral causing Jay to become known around the world. His mother has since passed, but Jay continues to tour internationally as an advocate for the Alzheimer's Association, and the song has gone on to raise over \$100 million dollars to help fight the disease.

Jay has been featured on NBC's The Voice, ABC World News, PeopleTV, Pickler & Ben, and in People & Forbes Magazine, among others. He was selected as The Highway Find on Sirius XM with his song "Sounds Good To Me", won the 2022 Country Now Awards as Favorite Competition Contestant, and was recognized as one of Music Mayhem Magazine's 2023 Artists to Watch.

Celebrated for his philanthropic work, Allen was presented The Caregiver Award by The National Alzheimer's Association, was personally invited to The White House by First Lady Dr. Jill Biden, and made history by performing the first ever concert in the U.S. Capitol Building.

#### Art Institute of Chicago

The Art Institute of Chicago has showcased magnificent art collections for more than 150 years. Known for its Impressionist, Post-Impressionist, and American paintings, the institute houses more than 260,000 works of art. At one million square feet, it provides a fascinating journey into the more than 5,000 years of human expression from cultures around the world.

#### **Museum Campus**

Walking distance from the hotel! The Museum Campus is a pedestrianfriendly park consisting of 57 acres along the edge of Lake Michigan. It is home to three of Chicago's most popular museums: the Adler Planetarium, the Shedd Aquarium, and the Field Museum of Natural History.

#### **Magnificent Mile**

Considered one of the Great Avenues of the World, Magnificent Mile is home to shops, restaurants, outdoor exhibits, and much more. Officially Michigan Avenue, this is a definite must-see during a visit to Chicago.

#### WILLIS TOWER

Once the world's tallest building, Willis Tower is still way up in the clouds as the third tallest building in the Western Hemisphere today. Though it functions as an office building, the skyscraper's 103rd-floor Skydeck Chicago draws 1.7 million annual visitors for a trip out onto The Ledge, an enclosed glass balcony extending 4 feet (1.2 meters) out over the city, as well as panoramic views that-on clear days-extend as far as Indiana, Michigan, lowa, and Wisconsin. Simply walking by is an experience in itself as the Chicago Theatre marquee and six-story-high CHICAGO sign are striking icons on State Street. #### **State Street Shopping**

One of Chicago's historic shopping destinations, State Street became famous when Frank Sinatra sang its praises in his song "Chicago." #### Soldier Field


Home to the Chicago Bears, Soldier Field is located within Grant Park—only six blocks from the Hilton Chicago.

#### Chicago Loop

#### GRANT PARK & BUCKINGHAM FOUNTAINS

Clarence F. Times are subject to change when large events take place in or around Grant Park. While in operation, every hour on the hour for 20 minutes the Fountain produces a major water display and the center jet shoots 150 feet into the air. The initial major display begins at 9:00 a.m. and thereafter, is every hour on the hour. Beginning at dusk, every hour on the hour for 20 minutes the Fountain's major water display is accompanied by a major light and music display. The final display of the evening begins at 10:35 p.m.







Forming a length of 156 miles when combined, the Chicago River is a system of rivers and canals that characterize the infamous skyline of Chicago today. The river, running through the city, including the city center Chicago Loop, is evident of man-made design and infrastructure when completed craftily. In 1887, the river was reversed through civil engineering by taking water from Lake Michigan and discharging it into the Mississippi Watershed.

The goal of GFWC Boosters is to support GFWC at the Convention site and in our communities throughout the year. We encourage you to attend the 130th GFWC Annual International Convention in Chicago and join the GFWC Boosters in our hospitality suite- McCormick Boardroom 4th Floor. ### **CREDENTIALS & VOTING**

All GFWC members are invited to attend the GFWC Convention. However, not all attendees have voting privileges. In accordance with GFWC Bylaws, Article VIII, each club is permitted a certain number of voting delegates.

To determine your voting status during GFWC Business Sessions, credential cards are issued onsite at the GFWC Registration Desk. Credential cards are not mailed in advance and must be picked up onsite. When completing your registration, indicate your voting status and the capacity in which you are a delegate. Your voting status is then verified by the GFWC Credentials Committee.

#### Club Level

Two members from every Woman's, Junior Woman's, or Juniorette club of 20 or fewer members may be voting delegates.

For each additional 10 members (or major fraction of 10) one more delegate may represent the club. For example, a club with 56 members may have six voting delegates: two for the first 20 members, one for having 21-30 members, one for having 31-40 members, one for having 41-50 members, and one for having an additional six members, which is a major fraction of 10.

To be eligible to vote, attendees must belong to a club whose dues were submitted by its State Federation to GFWC by February 15, 2024.

A delegate must pay the registration fee for the entire convention to be entitled to vote. Daily registration fee does not include voting privileges.

#### **Board Level**

All members of the 2022-2024 GFWC Board of Directors and of the GFWC Standing and Special Committees are eligible to vote.

#### **Region Level**

The Vice President, Secretary, and Treasurer of each Region are delegates. The Region President is a delegate as a member of the GFWC Board of Directors.

#### State Level

If your State has any of the following elected officials, they may be delegates by virtue of their office: Presidentelect; First, Second, and Third Vice Presidents; Secretary; Corresponding Secretary; Treasurer; and the Directorelect of Junior Clubs. The State President and State Director of Junior Clubs are delegates as members of the GFWC Board of Directors. State Community Service Program, Special Program, or Advancement Area Chairmen may be delegates. Your State may have additional elected positions, chairmanships, and/or officers, but those with titles other than those mentioned will have to be delegates from their clubs or in some other capacity.

#### **GFWC National or International Club**

One delegate from each such club.

#### National Organization or International Affiliate

One delegate for each such organization.

### HELPFUL TIPS AND INFORMATION

To qualify as a voting delegate, a full Convention registration fee must be paid. Daily attendees do not receive a vote.

After checking into the hotel, your first stop should be the GFWC Registration and Welcome Desk to pick up your Convention materials. The Credentials Committee will be ready to assist with any questions.

Each delegate must pick up and sign for her own credentials. Voting delegates receive a white voting card. The Credentials Committee keeps a portion of the card, and the other portion is yours to use during voting.

If you register in a non-voting capacity, you receive a marked non-voting card, and you are not permitted to vote at Convention.

Only an accredited delegate may introduce motions, debate, and vote.

No delegate may represent more than one organization or be entitled to more than one vote.

No proxy voting shall be allowed.

A member registering as a nonvoting member may, upon proper clearance by the Credentials Committee, be transferred to a delegate status during a business session meeting.

The Bylaws Committee requests authorization to make editorial changes throughout the GFWC Bylaws to render the document more job-title-specific. For example: "the International President" vs. "she."

**RATIONALE:** To update language to reflect the GFWC Diversity, Equity, and Inclusion Statement and align with GFWC Bylaws, ARTICLE XVIII, *Ethical Standards*, Section 18.5 Discrimination.

In order to be recognized by GFWC, a State Federation shall elect a President, Secretary, Treasurer, and such additional officers or directors as the State Federation may provide in its bylaws. State Federations shall hold a minimum of one statewide meeting each year of the administration. At least one of the statewide meetings during an administration shall be a state convention. State Federations may establish districts, if desired.

Insert "bylaws" after "Federation" in the third sentence. Strike "may provide inits bylaws" in the third sentence. Strike "State" in the fourth sentence. Strike "statewide" in the fourth and fifth sentences and insert "federation-wide." Strike "state" in the fifth sentence.

Woman's Clubs, Junior Woman's Clubs, and Juniorette Clubs may join together to form a State Federation [or District of Columbia Federation.] There shall be no more than one federation per state [or the District of Columbia]. In order To be recognized by GFWC, [such] a State Ffederation shall elect a President, Secretary, Treasurer, and such additional officers or directors as [provided in] the State Ffederation [bylaws] may provide in its bylaws. State Federations shall hold a minimum of one statewide [federation-wide] meeting each year of the administration. At least one of the statewide [federation-wide] meetings during an administration shall be a state convention. State Federations may establish districts, if desired.

**RATIONALE:** To Clarify. Should this Bylaw amendment be adopted, the "District of Columbia Federation" will be inserted where appropriate throughout the Bylaws.

#### **ENVIRONMENT**

#### **RESOLUTIONS PROPOSED TO BE AMENDED**

**160-070** Household Waste Management (Convention 2021: Includes "Household Hazardous Waste (HHW)," Convention 1988; and "Waste Management and Recycling," Convention 1997)

WHEREAS, The disposal of household waste, including the disposal of household hazardous waste (HHW), which contains corrosive, toxic, flammable, or reactive ingredients, can:

- Pollute the environment;
- · Harm plant and animal life;
- · Leach into soil and ground water;
- · Produce toxic gases or spontaneously combust; and

WHEREAS, The use of green products and recycling conserves natural resources and helps protect the environment by preserving the quality of the environment and reducing the quantity of solid waste; and

[WHEREAS, Single-use plastics are generally not compostable or biodegradable, and can make their way into the food chain and water supply generating a threat to the environment, marine life, wildlife, and humans; and]

WHEREAS, The reduction of packaging used on products for the household decreases the amount of household waste; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to:

- Support the use of green products and substitution of non-hazardous products for household cleaners, yard care, and car maintenance;
- [Support public education regarding alternatives to

# single-use plastics and encourage the elimination of single-use plastic products by individuals and businesses;]

- Promote public awareness of the dangers of improper disposal of household hazardous waste;
- Encourage local and state agencies to provide and promote public participation in recycling, household hazardous waste "drop off" programs, collection days, and permanent collection sites, and to provide educational materials through the classroom, publications, and the media;
- Encourage retailers and manufacturers to reduce overpackaging, to promote recycling within their businesses, and to provide information to households on safe disposal and recycling;
- Support legislation that encourages continued development of and standards for green products, and encourages efforts to increase appropriate recycling.

Rationale: To expand.

**160-100 Protection of Oceans** (Convention 2011; Reviewed 2015; Amended 2019; Amended 2021)

WHEREAS, Oceans contain approximately 97% of the earth's water supply, generate approximately 50% of the earth's oxygen, and provide almost 20% of the animal protein humans eat, provide vital natural resources, are a frontier for scientific exploration, and are critical to the world economy and national security; and

WHEREAS, Carbon dioxide from the atmosphere has been shown to cause ocean acidification, which may cause serious biological and economic harm; and

WHEREAS, Only 13% of the world's ocean waters constitute marine wilderness and the preservation and study of such areas is necessary to understand the restoration of





degraded marine ecosystems; and

[WHEREAS, 90% of the ocean trash is generated by single-use plastics resulting in serious harm to the deep seas, coral reefs, beaches, rivers, and ocean life including birds and turtles; and]

WHEREAS, Programs dealing with ocean resources, preservation, and restoration do not reflect a unified approach towards preserving and restoring the oceans; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- The development of an international ocean policy that unifies and coordinates ocean preservation and restoration efforts;
- Policy decisions to ensure the conservation and longterm sustainability of marine resources;
- Efforts to manage fisheries, protect marine habitats, and maintain and restore marine ecosystems;
- [Elimination of the use of non-essential single-use plastic products;]
- Efforts by the State Department and US Agency for International Development to address global problems of ocean-borne plastic waste and other pollution debris, including plastic waste cleanup, waste management, and recycling.

Rationale: To expand.

#### **HEALTH AND WELLNESS**

#### **RESOLUTIONS PROPOSED TO BE AMENDED:**

**170-010 Autism Spectrum Disorder** (Convention 2011; Amended 2015; Amended 2019; Amended 2021)

WHEREAS, Autism Spectrum Disorder (ASD) is a developmental disability with a wide variation in the type and severity of symptoms and occurs in all ethnic, racial, and economic groups; and

WHEREAS, The cost of lifelong care of ASD can be reduced with early diagnosis and intervention; and

WHEREAS, [While all] A number of states have passed laws requiring ASD coverage by private health insurers resulting in more for children with ASD receiving treatment[, some states limit coverage by age, dollar, or hour maximums resulting in disparities]; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to [support] advocate for:

- Legislation requiring private and public-sponsored [comprehensive] health insurance coverage for ASD intervention programs;
- Expanded insurance coverage for services, therapies, and treatment of individuals of all ages with ASD;
- · Continued research into the causes, treatment, and prevention of ASD.

Rationale: To update.

**170-020 Breast Cancer** (Formerly "Breast Cancer Examination;" Convention 1986; Amended and Reaffirmed 1989; Reviewed 1993; Amended 1997; Amended 2001; Amended 2005; Amended 2010; Amended 2014; Reviewed 2018; Amended 2021)

WHEREAS, The Centers for Disease Control and Prevention reports that one in eight women and one in more than 800 men will develop breast cancer in their lifetime; and

WHEREAS, The stage at which breast cancer is diagnosed is a major predictor of survival, with early detection significantly lowering the mortality rate; and

WHEREAS, Screening methods, including physical [clinical breast] examination, self-examination, laboratory tests, genetic tests, and [mammography, all] assist in early breast cancer detection: and

### [WHEREAS, Dense breasts make detection of cancer with mammography more difficult; and]

WHEREAS, Common treatments of breast cancer, including mastectomies, breast conserving surgery, radiation, chemotherapy, [hormone therapy,] and lymph node removal[,] and dissections extend life [lives]; and

WHEREAS, Many breast cancer patients are forced to go home from the hospital hours after surgery due to hospital-stay restrictions imposed by their insurance companies; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- Educational campaigns raising awareness of early diagnostic and screening tools available to detect breast cancer[, the increased risk associated with dense breasts,] and the available treatment options;
- [Research into breast density and the appropriate imaging and procedures to diagnose early breast

#### cancer;

- Legislation which requires patient notification of dense breasts and insures for health coverage parity for breast cancer diagnostic imaging;]
- Legislation [Codification] requiring insurance coverage for a 48-hour minimum hospital stay for mastectomy and a 24-hour minimum hospital stay for all other breast cancer surgery.

Rationale: To expand and update.

**170-030 Cancer** (Convention 2021: Includes "Gynecologic Cancer," Convention 2006; and "Cancer," Convention 2011)

WHEREAS, Cancer is a complex group of diseases with multiple causes; and

WHEREAS, According to the National Cancer Institute more than 1.8 [1.9] million people develop cancer each year and the Centers for Disease Control and Prevention estimates the annual cost of treatment exceeds \$174 [209] billion; and

WHEREAS, Approximately half of all cancer deaths are linked to modifiable lifestyle factors; and

WHEREAS, Education about risk factors, symptoms, and diagnostic tools available to screen for cancer reduces latestage diagnoses and mortality; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- Educational awareness campaigns that target modifiable risk factors and the availability of screening and treatment options;
- Funding for the research and development of prevention strategies, comprehensive screening methods, treatment options, and cures.

Rationale: To update.

**170-050 Diabetes** (Convention 2003; Amended 2008; Amended 2012; Amended 2016; Amended 2021)

WHEREAS, According to the Centers for Disease Control and Prevention, diabetes is a leading cause of death in the United States, the number of children and adults with diabetes is rising, and statistics show many more cases are undiagnosed; and

WHEREAS, Diabetes is known to be a causative factor in other health problems, including but not limited to cardiovascular, renal, neurologic, [vision,] and dental diseases, and some [as well as] complications in pregnancy [and dementia]; and

WHEREAS, To manage their disease, those with diabetes must have access to a healthy, balanced diet and medication, and must maintain a level of physical activity; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- Enforcement of laws prohibiting discrimination against those with diabetes;
- · Insurance coverage for comprehensive medical care for those with diabetes;
- Programs to [that] train [education and] school and childcare personnel [professionals and home-based providers] to identify symptoms and facilitate treatment options for students with diabetes;
- Education about the role a healthy diet and physical activity play in treating and reducing the onset and control of diabetes;
- Increased funding for diabetes research and prevention programs;
- · Improved awareness of prediabetes symptoms among healthcare providers and people at risk.

Rationale: To update.

**170-070** Food, Drug, Cosmetic, and Medical Product Regulation and Safety (Convention 2021: Includes "Food, Drug, Cosmetics," and "Medical Products Regulation," Convention 1989; and "Food Safety," Convention 2005)

WHEREAS, The General Federation of Women's Clubs was instrumental in the passage of the Pure Food and Drug Act, which led to the establishment of the Food and Drug Administration to protect the health and safety of consumers; and

WHEREAS, The Food and Drug Administration, the Centers for Disease Control and Prevention, and the U.S. Department of Agriculture regulate items, including food, drugs, cosmetics, and medical devices, and guard against foodborne illnesses; and

WHEREAS, There is ongoing demand for consumer protection from serious illness or health complications; therefore





RESOLVED, That the General Federation of Women's Clubs urges its member clubs to [support]:

- Advocate for f[F]unding to accelerate research and development to ensure availability of new medical treatments and to provide protection to consumers;
- Support s[S]trengthening the consumer protection regulations of the Food and Drug Administration and the Food Safety Modernization Act;
- · Support [Reasonable] public health and safety laws.

Rationale: To update.

**170-100 Heart [Cardiovascular] Disease in Women** (Convention 2011; Amended 2015; Amended 2019; Amended 2021)

WHEREAS, Heart [Cardiovascular] disease[, which includes stroke,] is the number one killer of women with an overall increase in heart attacks approximately 10 years after menopause and is deadlier than all forms of cancer combined; and

WHEREAS, Studies show:

- [Many] Approximately 55% of women [do not recognize cardiovascular disease as their greatest health threat] are unaware that heart disease is the leading cause of death in women;
- [Cardiovascular disease is the number one killer of new mothers;
- Menopause can accelerate cardiovascular disease risk factors;
- Most cardiac and stroke events can be prevented through education and lifestyle changes;]
- Women often present with different heart attack symptoms than men, resulting in a delay in diagnosis and treatment when a heart attack occurs;
- Women account for less than one-third of all subjects in heart cardiovascular disease studies; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

 Public awareness campaigns on women's heart [cardiovascular risk factors,] health and [including] heart attack [and stroke] symptoms; · Efforts to improve research, prevention, diagnosis, and treatment of heart disease and other cardiovascular diseases in women.

Rationale: To update.

**170-140 Nutrition and Obesity** (Convention 2021: Includes "Nutrition," Convention 1976; "Obesity Prevention," Convention 2011; and "Reducing Obesity in Youth," Convention 2019)

WHEREAS, Nutrition is a critical factor in both the prevention of and recovery from disease, illness, and injury; and

WHEREAS, Overweight adults and children are at increased risk of multiple health problems and chronic diseases; and

WHEREAS, Obesity has reached epidemic numbers placing a burden on the healthcare system; and

WHEREAS, Research has shown that early childhood is an important time for developing dietary and physical activity behaviors that support health and may help prevent obesity, and

WHEREAS, Healthy eating can improve a child's learning ability, academic performance, and mental, social[,] and physical wellbeing; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to:

- Support a national strategy to reduce obesity;
- Promote development and implementation of programs on healthy nutritional habits and fitness counseling;
- Encourage the restaurant industry and school nutrition programs to provide reasonable food and beverage portions to enhance overall healthy living and improved quality of life;
- [Engage local, state, and national leaders to promote and sponsor salad bars in schools to promote increased consumption of fruits and vegetables and to help children develop good eating habits;]
- Support the inclusion of prevention, management, and reduction of obesity in medical, nursing, and allied health training programs.

Rationale: To update.

**170-150 Organ and Tissue Transplantation** (Formerly "Organ and Tissue Transplants;" Convention 1988;



### **RESOLUTIONS**

Amended 1992; Amended 1996; Reviewed 2000; Reviewed 2003; Amended 2007; Reviewed 2011; Amended 2015; Amended 2019; Amended 2021)

WHEREAS, The transplantation of vital organs and tissues, including vascularized composite allografts (i.e., hands, fascial tissue, limbs, etc.), is an accepted medical procedure; and

WHEREAS, Tissue banking is an unregulated business venture that has become lucrative through fees charged for processing and handling; and

WHEREAS, Only 60% of potential organ and/or tissue donors execute an organ and/or tissue donor card, and inform healthcare providers and family members of their desire to be a donor; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- Public awareness campaigns that educate individuals about the need for organ and tissue donation and the ability to express their personal preferences by signing a donor card, Advance Health Care Directive (Living Will), and/or Health Care Power of Attorney[, and designating donor status on their driver's license];
- Legislation requiring The Organ Procurement and Transplantation Network (OPTN) allocate available donations that take into consideration the patient's medical status and the likelihood of a successful transplant;
- Legislation requiring insurance coverage for all aspects of the organ and tissue transplantation process and the long-term costs associated with the transplant;
- Legislation regulating tissue banking operations and the disposal of excess tissue.

Rationale: To update.

**170-160 Preventable Disease** (Convention 2021: Includes "Immunization for Prevention of Childhood Diseases," Convention 1992; "Prevention, Detection, Control and Cure of Diseases and Illnesses," Convention 1977; and "Tuberculosis Prevention, "Convention 1992)

WHEREAS, The incidence of disease is costly to society; and

WHEREAS, Preventable diseases have surged due to the lack of vaccinations; resulting in epidemics and needless loss of life; therefore

RESOLVED, That the General Federation of Women's Clubs

urges its member clubs to:

- Support legislation mandating medical insurance companies cover consumers with pre-existing conditions;
- Promote and support education and research on prevention, control, and cure of disease, including the necessity and safety of immunizations;
- Support the Centers for Disease and Control and Prevention recommendations for vaccinations;
- Support the World Health Organization's Global Vaccine Action Plan;
- [Support the World Health Organization's Immunization Agenda 2030 strategies and core principles;]
- Support local, state, and federal health departments, health care providers, and health organizations in the early detection [of diseases].

Rationale: To update.

#### 170-170 Sexual and Reproductive Healthcare

(Convention 2021: Includes "HIV/AIDS," Convention 1992; and "Sexual and Reproductive Healthcare," Convention 1997)

WHEREAS, Sexually-transmitted infections, including HIV/ AIDS and Human Papillomavirus (HPV), both globally and inthe United States:


- Endanger the lives of both women and men;
- Endanger pregnant women and unborn babies;
- **G[c]**ontinue to spread due to lack of education, symptoms, and access to contraceptives and vaccines, refusal to be vaccinated, and risky sexual and behavioral choices; and

WHEREAS, Health issues for women and infants are also increased by such risk factors as: [including inadequate prenatal care, low infant birth weight, premature birth, and neonatal, infant and maternal mortality, the age of the mother, and postpartum depression;]

Inadequate prenatal care, low infant birth weight, premature birth, and neonatal, infant and maternal morbidity and mortality;

The age of the mother, particularly for children born to teen mothers;





RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

- Legislation and funding for access to comprehensive healthcare:
- Research to develop treatments and cures for sexuallytransmitted infections;
- Development and implementation of programs and services on reproductive health and rights such as sex education, sexually-transmitted infections, family planning, perinatal care, well-baby and well-children, and family-life parenting.

Rationale: To condense and update.

**170-210 Tobacco and E-Cigarettes** (Formerly "Tobacco and Young People;" Convention 1997; Reviewed 2001; Amended 2005; Reviewed 2009; Amended 2013; Amended 2017; Amended 2021)

WHEREAS, Cigarette smoking has declined in the United States in recent years, but use and popularity of e-cigarettes, [vaping devices,] smokeless tobacco, and other tobacco products are increasing[,] and their long-term impact on health is not fully understood; and

[WHEREAS, Every day in the United States, thousands of youth smoke their first cigarette or e-cigarette, and many become daily smokers; and

WHEREAS, All states have passed legislation prohibiting the sale of e-cigarettes to underage individuals, and most states require a retail license to sell e-cigarettes over the counter; and

### WHEREAS, Proven cessation treatments continue to be underutilized by individuals who smoke;]

WHEREAS, Manufacturers of e-cigarettes are not required to report their products' ingredients, making the amount of nicotine or other potentially harmful or addictive substances unknown; and

WHEREAS, the Food and Drug Administration has the authority to regulate tobacco product standards and has chosen not to prohibit menthol or flavored tobacco-products; therefore

RESOLVED, That the General Federation of Women's Clubs urges its member clubs to support:

 Development and implementation of a public awareness campaign to address the addictive qualities

- and hazards of long-term tobacco [and e-cigarette] use;
- Enforcement of existing laws prohibiting the marketing and sale of tobacco and e-cigarettes to minors;
- · Legislation requiring manufacturers of e-cigarettes to provide product ingredient information;
- Access to and insurance coverage for effective nicotineaddiction treatments [that are comprehensive, barrierfree, and widely promoted].

Rationale: To update.
